<p>d. DAS Representative's Report</p> <p>e. Laney Eagle</p>	<p>canceled. Standing meeting; chancellor's office canceled the meeting. There is no VP of finance to be co-chair; as co-chair, President Bourgoin will go ahead with the meeting.</p> <ul style="list-style-type: none"> • There will be no presentations to FPC; if something unpredictable happened since you submitted your CPR or APR, you could present change of circumstances; can submit an amended request; this is a new procedure. • CBT submitted their report and suggested adding a few minutes of class time, we can collect a lot more money from the state; this idea was already presented by President Gilkerson when she first arrived; PFT must approve and we must update course outlines to reflect; leeway in reducing the passing time; will be discussed with Chairs and all colleges must have the same block schedule. • CBT promised on October 25th the introduction of software to do this. <p>In contact with Calbright College; senior VP of External Relations; conversation became combative on her part; she wants new chancellor at a meeting; the president doesn't want to cooperate with colleges; discuss BCC's resolution.</p> <p>Senator Brownfox presented the Laney Eagle to Vina Cera for her curriculum help and her knitting.</p>

The Facilities Committee asked the district for how to spend funds; Laney gets 46% of funds; percentages based on buildings needing to be built at each campus : infrastructure, technology, and ?; colleges still get to decide the order of what they will do first...we want to leverage state funds; theater has funding. PGC; if they agree it can go to board-hire someone to manage this effort at the district.

c. FabLab resolution (Barkdull)

Resolution in Support of Building a New FabLab Unanimously Approved on October 15, 2019

WHEREAS the Laney College FabLab serves as a learning resource for all Laney College students, serving over 1000 students since its opening in 2016.

WHEREAS the students the Laney College FabLab has served come from many departments across campus including, but not limited to, humanities, media communications, cosmetology, culinary arts, sociology,

WHEREAS the use of FabLabs has been proven to increase diversity¹ , equity¹ , self efficacy² , and creative confidence ³ among students.

WHEREAS the current size of the Laney College FabLab is unsustainable for an increasing number of students visiting the lab. Currently, the fablab can only safely serve about 20 students at a time.

WHEREAS the Laney College FabLab engages students with diverse learning styles and provides students with the industrial tools and software needed to make almost anything while gaining an understanding of the machines, materials, design process, and engineering that goes into invention and innovation.

WHEREAS the Laney College FabLab provides students with opportunities to collaborate and share knowledge with students in different disciplines.

WHEREAS the Governing Board of Trustees of the Peralta Community College District passed resolution

18/19-31 acknowledging the value of Peralta's FabLabs and strongly supporting the further growth and development of the Laney College FabLab.

WHEREAS many FabLabs across the country are currently incorporated as part of a library. Examples include the UCSF Library, the College of San Mateo Library, the Hunt Library at NC State, the University of Texas at Arlington Central Library, the Douglas Library at Rutgers University, the District of Columbia Public Library, and the San Jose Public Library.

WHEREAS learning resources are defined as any tool that helps teachers teach and students learn.

BE IT RESOLVED that the Laney College Faculty Senate acknowledges the FabLab as a valuable learning resource for students.

BE IT FURTHER RESOLVED that the Laney College faculty senate recommend the FabLab be located in the new Library & Learning Resource Center, if possible, or to a larger and more accessible space on campus.
