Annually each of the Peralta Community College District colleges is given an allocation of Measure E funds to directly support instruction. This is a two-year spending plan and the District Office reserves the right to make adjustments to 50% law compliance. Under such parameters, the proposal presents a plan for allocating the available dollars in alignment with the intent and language of the voter-approved parcel tax.
