BACKGROUND / SUMMARY

The Accrediting Commission for Community and Junior Colleges (ACCJC), Western Association of Schools and Colleges, took institutional action on the accreditation status of Laney College in an ACCJC action letter on June 28, 2021 that included ten district compliance requirements and eight fiscal issues from the Special Team Report in January 2021 to be addressed in a Follow-Up Report.

The College continues on Probation with a Follow-Up Report due October 1, 2021, and a team visit. Issues addressed in this report were detailed in the Peer Review Team Report March 2021 and the Special Team Report December 2020. The College was also required to create a Teach Out Plan and submit it by October 1, 2021.
