Canvas Training and Support Available Now!

On Tuesday, October 3rd, the Laney Faculty Senate voted to approve the creation of the Distance Education Committee at Laney. Faculty Senate President Donald Moore is seeking membership for the committee. Here are the qualifications for membership:

- Willingness to attend two 2-hour meetings twice a month during Fall 2017 semester
- Online teaching experience (either fully online or hybrid) within the last two semesters while meeting the criteria for teaching online as set forth in AP 4105
- Completion in training regarding the use of the OEI Rubric in assessing online/hybrid courses
- Willingness to commit to ongoing training in effective practices in DE and the use of the OEI rubric
- Willingness to conduct assessments of online/hybrid courses using the OEI rubric (approximately 5-6 during fall semester)
