#### 1) Healization Club Chartering. (6 min)

AI motions, JG seconds. Purpose of the club is creating a safe space Monday to Thursday in SC 411. AI motions to vote. AM, AI, CT, GJ, SZ, JG, and MT vote yes.

### 2) United Painters Club Chartering. (6 min)

Mallory - club representative. Transfer track program, first gen low income latinX students, Support students transferring coc from to a uc/csu. Workshops on how to fill out fafsa, college applications. Networking opportunities for those inin transfer track program. Offer that space to more incoming LatinX students. To prosper in higher education. To see numbers rise in academic institutions. Already have a lot of members. Chair and co chairs. All of them are one. First puente club at Laney. Open to everyone. Specifically puente who in puente track program. Recharting this year. GJ motions to talk, AI seconds the motion. CT asks meeting time. Mallory responds monday 12 pm - 1pm. MT asks how it's separate from LatinX club? Mallory says it's an extension track program. LW asks how they will students with transferring such as ASSIST/UC TAG.. Did workshops before creating the club. Do work with tag system and how to fill out pigs. Workshops where people can physically bring stuff to LatinX. Fill out application step by step. Helpful for people don't have english as primary language. Angela Torres says they only get income from state - pertained to course materials. Gap between LatinX students and undocumented students. Build community aside from Puente. Puente would be more of a social aspect and community base club. SH asks about services for people who can't speak English. Once registration passes, only towers weeks til november 5 deadline. Someone gives contact information. October 18 - we start to call those people "from laney college - you're registered now and ask if they have a plan". More young people - better society. LW - ASLC would be umbrella of. Clubs can participate if wanted. Give them volunteer power. One or two from each club. Address Faculty to make an announcement - reminder there's voting - can register to vote online as well. MT booth to register. Dropoff boxes around alameda county days before election - early voting. WOuld go to precinct on voting day. Have to be a citizen to vote. JG - what is it exactly is he asking of ASLC. provide publicity towards his cause of voting? Single event, series of events? Tabling one day, another day. Club representative can encourager members to vote. FV suggest voting table at Club Rush. AI suggest icc club meeting. Training from monday to friday. CT suggests more dates. Can help with tabling as well. Monday-Thursday from 11 to 1. Atiya Rashada - Voter Laney Voters Hub - list of links. Students would scan code last year and fill it out. Phi Theta Kappa partnered. Dean of learning communities will communicate with Atiya for partners. National women league of voters this year. Only one day. At least two days a week. Charli suggests a couple days a week. Midday Wednesday class. Can do before and after. FV facility request? FV will ask everyone on Signal so she can give charlie list of volunteers.
