ASLC Constitution Amendments

There was a motion to discuss the ASLC Constitution Amendments by Justin and seconded by Taylor. Votes were unanimous.

Owen went into more detail about the differences between the new ASLC constitution and the old one. A question was asked by Kristina which was answered by Owen.

Owen called for a motion to approve the new version of the ASLC Constitution. Taylor motioned with Aniah seconded. The floor opened to voting. Voting was unanimous in favor of the constitution change. Motion carried.

Clubs for charter

Speech and Leadership club chartered to be a club. They plan to work with club members and fellow students work on their public speaking skills. They will host two speaking events this semester where members will stand before the student body to deliver a prepared speech.

Ahlam motioned to charter the Speech and Leadership club and was seconded by Justin. Voting was unanimous in favor of chartering the Speech and Leadership club. Motion carried.

Black Student Union chartered to be a club. BSU wants to spread awareness of and to celebrate black culture. BSU will host two events which are TBD.

Bianca motioned to charter BSU and was seconded by Jennie. Voting was unanimous in favor of chartering the Speech and Leadership club. Motion carried.

Construction Managers Association of America chartered to be a club. CMAA wants to work with potential students interested in becoming a construction manager. They will provide mentorships, a special program to get women interested in construction, and will host events called "Lunch and Learns" where CMAA will host current construction managers and have them speak and be open to questions from students interested in the construction trade.

Justin motioned to charter CMAA as a club which was seconded by Alex. Voting was unanimous in favor to charter the CMAA. Motion carried.

Puente Club chartered to be a club. Puente club wants to create social events that celebrate diversity and provide a safe place for people who are recovering from past trauma. They plan to host board game nights and celebrate fall holidays like Dia De Los Muertos.

Your Majesty motioned to charter Puente club and was seconded by Diamond. Voting was unanimous in favor of chartering the Puente club. Motion carried.

The Peralta Citizen student travel funds request.

The Peralta Citizen is looking for \$1324.57 to help with flight and lodging for one person. The event going on is called "MediaFest." It is a festival for college journalists to meet and create bonds that nature journalism. A person from Laney won an award given out by MediaFest.

Questions were asked by Justin including concerns over funding because ASLC has not received the full allocated funds and since the club budget was not gone over yet. A motion was made by Taylor to release \$350 contingent on if The Citizen representative can allocate the rest of the money from other sources. Motion seconded by Bianca. 10 votes were in favor to release the contingent funds with one abstained vote by Justin for reasons of budget concern. Majority rules and motion carried.

Owen formed a subcommittee tasked to find more vendors to add to the ASLC Vendor List. The subcommittee consists of Taylor, Kristina, Justin, and Ahlam.

A motion to extend the meeting by 5 minutes by Justin and seconded by Taylor. Motion carried.

Ahlam went over the Clubs budget allocation and concerns she had because of the budget.
