MULTI PURPOSE FIELD:

Estimate for Multi Purpose Field – Gilbane has new estimate, not 1.2 million for multipurpose. Now price is closer to \$650,000+. If multi use field add alternate is accepted we may have to raise baseball field 2" to accommodate extra spoil soil– Jim Springer.

Light Fixtures 5 feet candles for Multi Purpose field \$80 thousand higher for \$120 thousand for higher lumens. 25 year warranty by Musco, only manufacturer to provide it. Turf 3rd Party warranty, make sure Mondo provides it.

BASE BALL FIELD:

Home plate must be turf and to be replaced every 3 years. We want everything sown in and glue down the edges. Mondo to meet with Zapata, Gilbane and Ernesto about ball play. Alley White will set up.

Bleacher cost from Southern was presented; two types elevated vs. non elevated Verde recommends at Grade non-elevated, Based on Verde's recommendation that sight lines are OK. Dug outs may block side view. Use non-elevated versus elevated silver edition \$20 thousand estimated \$300/seat -to- \$150/seat.
