Graduating/Transfer Student: Scholarships will be awarded student(s) who are graduating or transferring by Spring 2021 with a 3.0 cumulative grade point average or higher.

Academic Excellence: Scholarships will be awarded to currently enrolled student(s) with at least six (6) units and 3.5 cumulative grade point average or higher.

International: Scholarships will be awarded to international student(s) with at least six (6) units and 2.5 cumulative grade point average.

Student Leadership: Scholarships will be awarded to student(s) who is/are an active member of a club or organization at Laney College and currently has a minimum of six (6) units and 2.0 cumulative grade point average or higher.

Financial Hardship: Scholarships will be awarded to full time student(s) who qualifies as a low income student and has a minimum of twelve (12) units and a 2.0 cumulative grade point average or higher.
