A. Student Community Ambassador Program: The Student Community Ambassador Program's purpose is to provide great safety for the campus community in a way that is respectful and supportive of Laney students, staff, and the surrounding community. Another purpose is to employ students in a meaningful job that includes training that will make them marketable for jobs after they leave Laney. ASLC Senator MC and ASLC Senator JMS will share info regarding the program. (Information/Action/10-15 minutes allocated time /ASLC discussion).

JMS says he is trying to get as much support from everyone from Laney College to present to the Board of Trustees. Start with ASLC and move along. The purpose is to create an ambassador program to build a connection on campus between students, staff and community. Meaningful job. It'll help develop a training or certificate program, in conjunction with Macro, community responder of Oakland. Macro works in conjunction with firefighters through police department. Primarily focused on Laney College right now.

There's a committee of faculty, students, etc who have been working for a month. Previously, there were student aid positions, but were taking off campus due to COVID. More to reinstate and give more training. OA asks for paperwork or a proposal packet and for members to come into ASLC meeting so they can talk about it and we can understand mission statement. CZ and Atiya Rashada agree. JMS and MC are part of it. Will be put on agenda as soon as JMS has paperwork.

B. Resources for the Unsheltered Workshop: ASLC Senator JMS will present the Unsheltered Workshop in hopes that ASLC can put the workshop in the newsletter and on social media to inform students (Information/Action/10-15 minutes allocated time /ASLC discussion).

Housing workshop. No money needed. Informational meetings at Laney. Flyer was sent out on Discord. JMS is hoping he can post it on social media and newsletter. And the campus event calendar.
